1.0 Scope of Work

In terms of Clause 1.1 of Instructions to Bidders, Section-1 of the bid documents, the Services covered under this Letter of Acceptance shall be as stipulated in Part-II Employer's Requirement of the bid documents (read with corrigendum referred above), uploaded on e-bidding portal, considered by the Consultant in the submission of their bid. The Services shall be carried out as defined in the Employer's Requirement. The scope of work covered under item (1&2) of BOQ has been slightly modified during negotiation and scope of work covered under item 3 to 7 remains unchanged. The modified scope of work covered under the negotiation offer letter dated 04.12.2019 under reference (vi) above is detailed below:

- Provide proven design and prepare a customized Basic Design which includes following headings

2.0 Accepted Rates/Cost and Payment Schedule

2.1 The accepted rates for various items of Services covered under this Letter of Acceptance are stipulated in the Bill of Quantities enclosed at Annexure-A to this Letter of Acceptance. The above accepted rates are inclusive of all taxes, duties, levies, cess, Royalties, insurances & all other incidental charges except Goods and Services Tax, required to fulfill the tender conditions including statutory deductions viz. TDS towards Income Tax and Goods and Services Tax (GST) etc. GST shall be paid as per clause 15.3 of SCC (Supply). GST shall be paid as applicable on the submission of GST Invoices. The subsequent RA bill shall be raised for payment upon submission of documentary evidence towards payment of GST collected on the previous bill to the GST Authorities. However, if subsequent bills are raised before return submission date of previous bill period, the documentary evidence towards payment of GST shall be provided within 7 days from the due date of such return filing. The Final bill/single bill payment shall be released on the undertaking by the contractor/supplier for providing evidence within 7 days from the due date of such return filing bill based on GST provision for due dates.

In terms of Clause No. 38 of General Conditions of Contract (GCC) for Consultancy, Clause No. 15 of General Conditions of Contract (GCC) for Supply Contracts and their relevant clauses of

SCC of the Bid document, in consideration of the Services and Supply performed by the Consultant under this Contract, the Employer shall make payments to the Consultant as specified therein.

3.0 Completion Period

In terms of Clause 1 (xiv) of General Conditions of Contract (GCC) for Consultancy and Clause 1.1 (d) of General Conditions of Contract (GCC) for Supply Contracts of the bid document, the entire Services and supply shall be completed in a period of **312 weeks** from the Effective Date. In terms of Clause 1 (xvi), 8.0 of General Conditions of Contract (GCC) for Consultancy, and its relevant clause of SCC of the Bid document, the Effective Date and Date of Commencement shall be 15 days from the issue of Letter of Acceptance.

4.0 (a)Submission of Performance Security

In terms of Clause 40 of Instructions to Bidders, Section-1 and Clause No. 31 of General Conditions of Contract (GCC) for Consultancy, and its relevant Clause of SCC of Bid document, within 28 days of receipt of this Letter of Acceptance, the Consultant shall furnish to the Employer a Performance Security in the form of Bank Guarantee as stipulated in Form CF-2 of Contract Forms, Section-7 of the bid documents, for an amount of Euro 7,60,608.00 (Euro Seven Lacs Sixty Thousand Six hundred Eight only) being amount equal to 10% (Ten Percent) of the Contract Value as stated in Relevant Clause of Special Conditions of Contract for Consultancy (SCC), Section-6 of the bid documents. In terms of Clause No. 31 of Special Conditions of Contract for Consultancy (SCC), Section-6 of bid documents the Performance Security shall remain valid up to 60 months from the date of Scheduled completion period.

4.0 (b) Submission of Professional Indemnity Insurance (PII)

The Consultant within four weeks from the date of Commencement shall submit the Professional Indemnity Insurance (PII) for the amount and with the validity as specified in terms of Clause No. 34 of General Conditions of Contract for Consultancy (GCC), Section-5 of bid documents.

5.0 Release of Bid Security

In terms of Clause 19.5 of Instructions to Bidders, Section-1 of the bid document, the bid security submitted by the Consultant with his bid shall be returned as promptly as possible on submission of the required Performance Security by the Consultant and signed the Contract.

6.0 Submission schedule (Key dates)

Submission schedule (i.e. Key dates) is attached as **Annexure-B** to this Letter of Acceptance.

7.0 Signing of Contract Agreement

In terms of Clause 41 of Instructions to Bidders, Section-1 of the bid documents, the Consultant shall enter into a Contract Agreement with the Employer for the Services covered under this Letter of Acceptance within the time limits as specified therein. The Consultant shall be informed by the

Employer about signing of Contract Agreement on receipt of acceptance of this Letter of Acceptance and Performance Security by the Employer.

8.0 Other Terms and Conditions

The execution of this Contract shall be governed by the various stipulations in the bid documents and its corrigendum/addendum referred above. Any deviation from the above conditions, submitted by the Consultant in their bid, if any, stands withdrawn.

9.0 Nomination of Engineer

In terms of Clause No. 1(x) of General Conditions of Contract (GCC) for Consultancy, Section-5 and Clause No. 1(x) of Special Conditions of Contract (SCC), Section-6 of bid documents it is to inform that "the Engineer Nominated for the subject Contract will be informed subsequently. The Consultant is advised to interact with the Nominated Engineer as will be informed for further instructions as regards to the provision of Services.

10.0 Acceptance of the Letter of Acceptance

The Letter of Acceptance dated 12.12.19 issued under reference (viii) above stands withdrawn, and this Modified Letter of Acceptance will hold good. This Letter of Acceptance is being issued in duplicate, in favour of the Consultant. The copy marked as "Duplicate" is required to be returned by the Consultant, duly signed and stamped on each page by the authorized signatory of the Consultant, as a token of Consultant's unconditional acceptance of the same so as to reach the undersigned within seven days of issue of this letter. This Letter of Acceptance shall constitute a binding Agreement between the Employer and the Consultant till such time a formal Agreement is signed between the Employer and the Consultant for the execution of this Contract.
