With reference to the above this is to inform to the Consultant that the bid for the subject work of "DA/DD/COR-OF/017: Engagement of Detailed Design Consultant (DDC) for Civil, Architectural and E&M Works for the design of Seven elevated stations (Panchgaon, Bilaspur, Dharuhera, MBIR, Rewari, Bawal & SNB), One Depot at Dharuhera, stabling lines at Manesar and elevated viaduct from Kherki daula Toll Plaza to SNB (62 Km) and detailed planning of proposed five underground stations for Sarai Kale Khan (SKK) – SNB RRTS Corridor.)" has been accepted by National Capital Region Transport Corporation Ltd (hereinafter termed as "Employer") at total contract value of Rs. 23,23,14,120.00 (Rupees Twenty Three Crore Twenty Three Lakh Fourteen Thousand one hundred twenty Only), hereinafter termed as "Contract Value", inclusive of all taxes, duties, levies, cess, royalties, insurances & all other incidental charges except Goods and Services Tax. The Scope of work, Services, accepted rates and terms / conditions applicable to this Letter of Acceptance are as under;

1.0 Scope of Work

In terms of ITB 1.1 (Instructions to Bidders), Section-1 of the bid documents, the scope of work covered under this LOA is as stipulated in Part-II Employer's Requirement Section-8 (Scope of Work), Section-9 (Design Basis Report for Stations, Design Basis Report for Viaduct, Station Design and Planning Criteria, Building Services, Interface Scheme Management, BIM EIR (Employer's Information Requirements) & Tender drawings, Track Plan) of the bid documents (read with the Addendums / Corrigendum referred above), uploaded on e-bidding portal, considered by the Consultant in the submission of their bid. The Services shall be carried out as per the above scope of work.

2.0 Accepted Rates/Cost and Payment Schedule

2.1 The accepted rates for various items of works covered under this Letter of Acceptance (LOA) are stipulated in **Annexure-A** (i.e. Accepted Bill of Quantity) enclosed to this LOA. The payment schedule is mentioned in Appendix-II, III, IV & V of Section -06 Special Conditions of contract. In terms of clause-24 of Special Conditions of contract the accepted rates / cost cover all costs associated for performing the entire scope of work, all duties, taxes, royalties, cess and other levies payable by the consultant under the Contract, or for any other cause (including standard specifications), as on the date 28 days prior to the deadline for submission of bids, shall be included in the rates and prices and the total Bid Price submitted by the consultant except Goods and Services Tax (GST).





GST will be paid extra as applicable on the submission of GST Invoices for first RA bill. The subsequent RA bill shall be raised for payment upon submission of documentary evidence towards payment of GST collected on the previous bill to the GST Authorities. However, if subsequent bills are raised before return submission date of previous bill period, the documentary evidence towards payment of GST shall be provided within 7 days from the due date of such return filing. The Final bill/single bill payment shall be released on the undertaking by the consultant for providing evidence within 7 days from the due date of such return filing for final bill based on GST provision for due dates.

2.2 Price adjustment in the contract will be in accordance with Section -06 Special condition of contract (SCC) clause-22 for GCC clause 20.3.

3.0 Completion Period

In terms of Section -06 Special condition of contract (SCC) clause-03 for GCC clause 1(xiv) of the bid documents, the entire work shall be completed in a period of **36 months** from the date of issue of this letter of acceptance (Effective date). The work shall be executed as per the Key Dates stipulated in, Annexure-A, of Special Conditions of Contract, Section-6. The service of this contract shall be commenced by Consultant from the date of issue of Letter of Acceptance (LOA) and this date is considered as effective date.

4.0 (a) Submission of Performance Security

In terms of Clause-40 of Instructions to Bidders, Section-1 and Clause No. 31 of General Conditions of Contract (GCC), and its relevant Clause of SCC of Bid document, within twenty-eight (28) days of the receipt of this Letter of Acceptance, the Consultant shall furnish to the Employer, a Performance Security in the form of Bank Guarantee as stipulated in Form COF-03 of Contract Forms, Section-07 of the bid documents, for an amount of Rs. 2,32,31,412.00 (Rupees Two crores thirty-two lacs thirty one thousand four hundred twelve Only) being amount equal to 10% (Ten Percent) of the Contract value as stated above. As per Section -06 Special condition of contract (SCC) clause-17 for GCC clause 31.0, the Consultant shall submit Performance Security in two parts of 5% each.

4.0 (b) Submission of Professional Indemnity Insurance (PII)

In terms of Clause 34.0 of General Condition of Contract (GCC), Section-5, the Consultant within four weeks from date of commencement shall submit Professional Indemnity Insurance (PII) for the amount equal to Contract Value with the validity from date of commencement till Five years after the date of issue of Completion Certificate.



5.0 Release of Bid Security

In terms of ITB 19.5 (Instructions to bidders), Section-1 of the bid document, the bid security submitted by the Consultant with his bid shall be returned upon the execution of the contract agreement and on receipt of the performance security by the Employer.

6.0 Deployment of Key Persons

The details of the Key Personnel /Experts as proposed by the Consultant in it's technical bid including negotiations are enclosed at Annexure-B to this LOA. In terms of clause 28.0 of General Conditions of Contract, Section-5, the Consultant shall deploy these Key Personnel/Experts in carrying out the stipulated scope of work under this LOA.

7.0 Signing of Contract Agreement

In terms of ITB-41 of Section-1 (Instructions to Bidders) of the bid documents, the Consultant shall enter into a contract agreement with the Employer for the works covered under this LOA within the time limits as specified therein. The Consultant shall be informed by the Employer about signing of contract agreement on receipt of acceptance of this LOA and Performance Security, by the Employer.

8.0 Other Terms and Conditions

The execution of this contract shall be governed by the various stipulations in the bid documents and it's amendments referred above. Any deviation from the above conditions, submitted by the Consultant in its bid, if any, stands withdrawn.

9.0 Nomination of Engineer

In terms of Clause No. 1(x) of General Conditions of Contract (GCC), Section-5 and Clause No. 2 of Special Conditions of Contract (SCC), Section-6 of bid documents, it is to inform that **Shri Virendra Kumar Pareek**, **Group General Manager/Design** of this organization has been nominated as the Engineer for the subjected Contract. The Consultant is advised to interact with the above official for further instructions as regards the execution of works.

10.0 Acceptance of the LOA

This Letter of Acceptance is being issued in Two Original and identical sets, in favour of the Consultant. Any one set may be retained by the Consultant and the other set is required to be returned by the Consultant, duly signed and stamped stating "Unconditionally accepted" on each page (including the enclosures) by the authorized

signatory of the Consultant, as a token of Consultant's unconditional acceptance of the same so as to reach the undersigned within seven days of issue of this letter. 2	The accepted rates are inclusive of all duties, taxes, royalties, cess and other levies payable by the consultant under the Contract, or for any other cause (including standard specifications), as on the date 28 days prior to the deadline for submission of bids, is included in the rates and prices and the total Bid Price submitted by the consultant except Goods and Services Tax (GST). GST will be paid extra as applicable on the submission of GST Invoices for first RA bill. The subsequent RA bill shall be raised for payment upon submission of documentary evidence towards payment of GST collected on the previous bill to the GST Authorities. However, if subsequent bills are raised before return submission date of previous bill period, the documentary evidence towards payment of GST shall be provided within 7 days from the due date of such return filing. The Final bill/single bill payment shall be released on the undertaking by the consultant for providing evidence within 7 days from the due date of such return filing for final bill based on GST provision for due dates.
m	The deployment of expert shall be multiple of one month at a time during the currency of the contract as per the requirement of Employer. Non deployment for such expert in time, the penalty of amount equal to 0.5% of the total contract value or revised contract value per month per key expert shall be imposed on pro rata basis for non deployment of key expert as per the agreed deployment schedule.
