- This is to notify you that your Bid dated 09.12.2021, for performing the obligations under "Bid No. DM/OM/COR-OF/144: Request For Proposal for Operations & Maintenance of the Delhi Ghaziabad Meerut Regional Rapid Transit System (RRTS)" for the Contract Amount of INR 1493,08,71,761/- (Indian Rupees One Thousand Four Hundred Ninety Three Crore Eight Lakhs Seventy One Thousand Seven Hundred Sixty One only) is hereby accepted by National Capital Region Transport Corporation Limited. The amount includes all the applicable taxes and duties (except Goods and Service Tax {GST}), royalties, cess and other levies payable by the contractor under the contract or for any other cause etc. The Operations and Maintenance services shall be carried out by the Operator as per the scope of work and payment shall be made as specified in Draft Operation & Maintenance Agreement.
- **2.** Formation of SPV: In terms of Clause 2.2.6 of RFP Document, you are required to form an appropriate Special Purpose Vehicle, incorporated under the Indian Companies Act, 2013 (the SPV), to execute the O&M Agreement and undertake the Operations & Maintenance of the Delhi-Ghaziabad-Meerut Regional Rapid Transit System (RRTS).
- 3. Submission of Performance Security: (a) In terms of Clause 2.27.1 of RFP Document, you are required to furnish the Performance Security o7 (seven) days prior to signing of O&M Agreement for an amount of INR 44,79,26,153/- (Indian Rupees Forty Four Crore Seventy Nine Lakhs Twenty Six Thousand One Hundred Fifty Three Only). The Performance Security shall be submitted in the form of irrevocable and unconditional guarantee as per the format set out in RFP document. Until such time the Performance Security is provided and the same comes into effect, your Bid Securing Declaration shall remain in force and effect, and upon such provision of the acceptable Performance Security pursuant hereto, the Bid Securing Declaration shall be considered as expired.
 - (b) In terms of Clause 2.27.2 of RFP Document, the Performance Security submitted by you shall remain in force and effective till the expiry of 6 (six) months from the Transfer Date (as defined in the Draft O&M Agreement).
- 4. <u>Signing of O&M Agreement:</u> In terms of Para (C) of Performa of Draft Operation & Maintenance Agreement (R2 Version), you are required to execute/sign the Operation & Maintenance Agreement within 45 Days from date of issue of this Letter of Acceptance (LOA). Further in terms of Clause 2.2.6 of RFP Document, you are requested to submit the following document prior to Execution of O&M Agreement.
 - a. a certificate of incorporation of the SPV;
 - b. memorandum of association of the SPV;
 - $c.\ articles\ of\ association\ of\ the\ SPV;\ and$
 - d. the then applicable shareholding pattern (on a fully diluted basis) of the SPV,
 - in each case, certified to be true by any director of the SPV.
- **Deployment of Key Personnel:** In terms of Article 13 (Key Personnel) of Draft Operation & Maintenance Agreement, you are required to deploy Key Personnel as proposed by you and accepted by NCRTC within 30 (thirty) days of signing of Operation & Maintenance Agreement. The details of Key Personnel to be deployed are tabulated under Table-1 below:

After quoting the lumpsum price the excel file shall be uploaded accordingly without changing the file name.			
	3	Bidders may provide any discount (in percentage) on the quoted LUMP SUM PRICE in the cell "E22" of the Sheet titled as "Letter of Price Bid"			
5	4	The rates/Unit price, lumpsum price, discount shall not be offered/quoted elsewhere in the Technical Bid otherwise the Bid of the Bidder may result in its rejection.			
	5	Whole Excel Sheet is Locked execept the Cells which are opened for quoting purpose. These Cell are highlighted in Blue Colour for ease of identification however, the Bidder should check the complete Financial Bid before quoting their offer. The Bidder shall mandatorily fill all such Blue Cells in the entire worksheet.			
	6	Prospective Bidders are advised to Quote rates/ lumpsum price upto two decimal places.			
	7	If the bidder fails to quote lumpsum price in sheet titled as "Letter of Price Bid", the Financial Bid of the Bidder may be treated as incomplete and non-responsive and may result in the rejection of the Bid.			
	8	Bidder should not tamper the Financial Bid (i.e. Excel File). If the Financial Bid is found to be modified by the bidder, then the same will be treated as incomplete and non-responsive and may result in the rejection of the Bid.			
	9	Bidder shall quote their offer in INR and only upto two places of decimal.			
	10	Errors will be corrected by the Employer for any arithmetic errors in computation or summation as per contract conditions.			
11	11	Price for all such works/goods/services required to be provided by the Contractor as per the Contract but not specifically indicated in the Financial Bid shall be deemed to be included in the Lumpsum Price.			
	12	For costs related to manpower, the associated deployment numbers must be provided by the bidder in the column titled as "number of manpower" of sheet titled as "Price Break up".			
13	13	If the unit rate is seriously unbalanced in the opinion of the Employer, the Employer may require the Contractor to produce detailed price analyses for any or all items of the "Price Break up" sheet. Employer reserve the right to negotiate the rates for cost items provided in worksheet titled as "Price Break up", in case unit rate is either on higher or lower side as the case may be, in the opinion of the Employer.
