With reference to the above this is to inform to the contractor that the bid for the subject work of **DM/TP/COR-OF/181**: "Hiring of various type of Vehicle on Monthly/ Daily basis for NCRTC on Rate contract basis" has been accepted by National Capital Region Transport Corporation Ltd (hereinafter termed as "Employer") on Monthly/Daily basis as per rate mentioned in Annexure-1 & 2, hereinafter termed as "**Rate Contract**, including all duties, taxes, royalties, cess and other levies except GST.

The Scope of work, Services, accepted rates, terms and conditions applicable to this Letter of Acceptance are given as under;

### 1.0 Scope of Work

In terms of ITB 1.1 (Instruction to Bidders) Section-1 of the Bid Document, the Scope of Work covered under this LOA is as stipulated in Section-6 (Scope of Work) of the Bid Documents. The Services shall be carried out as per the above scope of work. The requirement of hiring of various types of vehicle on Monthly / daily Basis for NCRTC shall be intimated separately.

# 2.0 Accepted Rates/Cost and Payment Schedule

2.1 The accepted rates for various items of works covered under this Letter of Acceptance (LOA) are stipulated in Annexure-1 & 2 (i.e. Accepted Rates) enclosed with this LOA. In terms of Section-02, Bid Data sheet clause ITB 14.7, the accepted rates contract price shall cover all costs incurred by the Contractor for performing the stipulated Services and all duties, taxes, royalties, cess and other levies payable by the Contractor under the Contract, or for any other cause (including standard specifications), except Goods and Services Tax (GST).

2.2 In terms of Clause 7 of GCC, the prices are fixed for first year and price variation shall be applicable from second year as per the formulae stipulated therein.

# 3.0 Completion Period

In terms of IFB of the Bid Documents, the contract period is **12 months** from the date of commencement. The commencement date will start from **01.03.2023**.

# 4.0 Submission of Performance Security

In terms of Clause 1 of Section-7, General Terms and Condition of Services of Bid Document, within twenty-eight (28) days of the receipt of this Letter of Acceptance, the Contractor may furnish to the employer, a Performance Security in the form of Bank Guarantee as provided in Contract Forms/Banker's certified cheque/Bank draft in favor of NCRTC, for an amount of **Rs. 1,00,000.00 (Indian Rupees One Lakks).** 

# 5.0 Signing of Contract Agreement

In terms of BDS-45 (Bid Data Sheet) Section-2 of the Bid Document, the Contractor shall enter into a contract agreement with the Employer for the works covered under this LOA. The Contractor shall be informed by the Employer about signing of contract agreement on receipt of acceptance of this LOA and on receipt of Performance Security, by the Employer.

# 6.0 Other Terms and Conditions

The execution of this contract shall be governed by the various stipulations in the Bid document and it's amendments referred above. Any deviation from the above conditions, submitted by the Contractor in its bid, if any, stands withdrawn.

# 7.0 Authorized representative / Officer In Charge -
