documents for an amount of INR 65,97,000/- (Sixty Five Lakh Ninety Seven Thousand Only). In case of Performance security submitted in the form of Bank Guarantee, Contractor shall use the Performance Security Form included in Section 9 (Contract Forms) of the Bidding Document.

3. The provision of Retention Money as stipulated in Clause No. 11.4.1 (e) & 11.21 of PCC (Part-A) of bidding document shall be applicable.
4. This Letter of Acceptance is being issued in two original and identical sets, in favour of the Contractor. Any one set may be retained by the Contractor and the other set is required to be returned by the Contractor, duly signed and stamped stating "Unconditionally accepted" on each page by the authorized signatory of the Contractor, as a token of unconditional acceptance of the same so as to reach the undersigned within seven days of issue of this letter.
5. The Commencement Date shall be 16.08.2024.
6. This LOA shall be a Binding Document until execution of formal contract agreement.
