In terms of clause 4.2 of PCC Part-A and clause 4.2.1 of PCC Part-B, within 28 days of issue of this Letter of Acceptance to the Contractor, the Contractor shall furnish to the Employer a Performance Security in any of the form stipulated in clause 4.2.1 of PCC for an amount of INR 1,51,87,581/- (Rupees One Crore Fifty One Lakh Eighty Seven Thousand Five Hundred Eighty One Only) i.e. 5% of accepted contract amount. In case of Performance security submitted in the form of Performance Bank Guarantee Contractor shall use the Performance Security Form included in Section 9 (Contract Forms) of the Bidding Document.
- 3. The provision of Retention Money as stipulated in Clause 11.4.1 (e) of PCC Part A and 11.4 (e) of PCC Part B shall be applicable.

- 6. This LOA shall be a Binding Document until execution of formal contract agreement.
