You have quoted the total Project cost excluding O&M for an amount of **INR 3.58 Cr/MWp** inclusive of all the applicable duties, taxes, royalties, cess, custom duty and other levies except Good and Service Tax (GST) payable by the Contractor under the Contract. The total project cost of **INR 10.74 Cr** will be considered for arriving at purchase price of plant as per schedule III (Purchase Price) of Power Purchase Agreement. The depreciation rate as per schedule III of section-9 will be 6.50% Per Year.
3. In terms of **Clause ITB 1 (Instructions to Bidders)**, Section-1 of the bid documents, the scope of work covered under this LOA is as stipulated in **Part-II Employer's Requirement** under the bid documents read with amendments referred above and considered by the Contractor in preparation and submission of their bid. The Work shall be carried out as per the referred Scope of Work.
4. The accepted unit rate of work covered under this LOA are stipulated in the Bill of Quantities enclosed as **Annexure-I** (Bill of Quantities) to this LOA. The accepted rates are inclusive of all the applicable duties, taxes, Goods and Services Tax (GST), royalties, cess, custom duty and other levies payable by the Contractor under the Contract, or for any other cause etc.
5. In terms of **Clause 1.2 (b) of IFB** of the bid documents, the Completion period for Design, Engineering, Supply, Installation, Testing, Commissioning of 3.0 MWp Roof Top Solar PV shall be 15 months from the Commencement date and 25 Years for O&M Services after Commissioning of Roof Top Solar PV. As per clause 18 of GCC, Section-7, the Commencement Date for the subject Contract shall be **01 (one) month** from the date of issue of LOA.
6. You are requested to furnish the Performance Security within 28 days in any of the form mentioned in the Clause 17 of GCC of Section 7 for an amount of **INR 1.07 Crores (Rupees One Crore Seven Lakhs Only)**, using for that purpose the Performance Security Form included in Section 9 (Contract Forms) of the Bidding Document.
7. In terms of Clause ITB 45.1 of Section-3 (Bid Data Sheet) of the bid documents, the Contractor shall enter into a Power Purchase agreement with the Employer for the works covered under this LOA within 75 days of issue of LOA and after submission of Performance Security.
8. In terms of **Clause 4.0 of General Conditions of Contract, Section-7**, it is to inform that **Mr. Suryaman Parasad Yadav, GM/Electrical, National Capital Region Transport Corporation Limited** has been nominated as the Engineer-in-Charge for the subject Contract. The Contractor is advised to interact with the Engineer-In-Charge for further instructions as regards the execution of works.
9. The execution of this contract shall be governed by the various stipulations in the bid documents and its amendments referred above. Any deviation from the above conditions, submitted by the Contractor in its bid, if any, stands withdrawn.
10. This Letter of Acceptance is being issued in Two Original and identical sets, in favour of the Contractor. Any one set may be retained by the Contractor and the other set is required to be returned by the Contractor, duly signed and stamped stating **"Unconditionally Accepted"** on each page by the authorized signatory of the

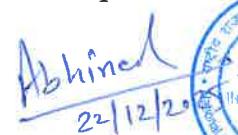
