2. In terms of clause 4.2 of PCC Part-A and clause 4.2.1 of PCC Part-B, within 28 days of issue of this Letter of Acceptance to the Contractor, the Contractor shall furnish to the Employer a Performance Security in any of the form stipulated in clause 4.2.1 of PCC for an amount of **INR 80,47,087/- (Rupees Eighty Lakh Forty Seven Thousand Eighty Seven Only)** i.e. 5% of accepted contract amount. In case of Performance security submitted in the form of Performance Bank Guarantee Contractor shall use the Performance Security Form included in Section 9 (Contract Forms) of the Bidding Document.
3. The provision of Retention Money as stipulated in Clause 11.4.1 (e) of PCC Part A and PCC Part B shall be applicable.
4. This Letter of Acceptance is being issued in two original and identical sets, in favour of the Contractor.
