This is to notify you that your bid dated **15.06.2026** for “**Begumpul (Underground) Namo Bharat Station**” for the **1st Year** License Fee of **INR 54,00,000/- (Rupees Fifty Four Lakh only) plus GST and Advertisement Tax as applicable** is hereby accepted by National Capital Region Transport Corporation Limited (NCRTC) for a **license period of 10 years**. The License Period may be further extended for the period of 5 years on mutually agreed terms and conditions. The work shall be carried out as per the scope of work specified in Part-II section 6 (scope of work) & Part-III section 7 (General Conditions of Contract) of Bidding documents and payment shall be made by the Licensee in accordance with the Price Bid.
- The above license fee is Excluding Goods & Service Tax (GST) & Advertisement Tax. The aforementioned license fee and any other charges shall be increased and escalated by 5% on compounding basis after completion of every one (01) year of license period (from 2nd year onward from the Commencement Date) as per clause 7.1 of GCC.

The License Agreement shall not in any way be construed as a lease or License of the said station or any part thereof, and only represents a contractual obligation of NCRTC to permit Exclusive Semi- Naming / Co-Branding Rights at said station only, on as is where basis as per as per clause 18.6 of GCC.

The modalities of submission of Interest Free Security Deposit/ Performance Security shall be as per clause 8 of GCC.
